Financial Summary

The net asset value (NAV) per share at 31 August was 1,999 pence. The year to date NAV total return was 0.7% and the share price total return was -13.1%. Over the same period, the Company's two indices; RPI plus 3% and MSCI All Country World Index (50% Sterling) were up +2.4% and +3.3% respectively. The average net quoted equity exposure for the year to date was 42%. The share price closed at 1,818 pence per share.


