
Financial Summary

The net asset value (NAV) per share at 31 August 2023 was 2,399 pence. The year to date NAV total return was 1.2% and the share price total return was -9.0%. Over the same period, the Company's two indices, CPI plus 3% and MSCI All Country World Index (50% sterling), were up 6.5% and 12.3% respectively. The average net quoted equity exposure for the year to date was 37%. The share price closed at 1,914 pence per share.




