

## Financial Summary


The net asset value (NAV) per share at 31 July was 2,659 pence. The year to date NAV total return was 16.8% and the share price total return was 24.6%. Over the same period, the Company's two indices; RPI plus 3% and MSCI All Country World Index (50% Sterling) were up 4.0% and 12.6% respectively. The average net quoted equity exposure for the year to date was 45%. The share price closed at 2,555 pence per share.











