

Financial Summary

The net asset value (NAV) per share at 31 July 2023 was 2,402 pence. The year to date NAV total return was 1.4% and the share price total return was -7.8%. Over the same period, the Company's two indices, CPI plus 3% and MSCI All Country World Index (50% sterling), were up 5.7% and 14.2% respectively. The average net quoted equity exposure for the year to date was 37%. The share price closed at 1,940 pence per share.

Before December 1998, when total return indices were introduced, the index is measured using a capital-only version.







Rothschild Capital Management Limited (JRCM) is a wholly-owned subsidiary of RIT and acts as RIT's Manager.
