Financial Summary

The net asset value (NAV) per share at 30 June was 1,944 pence. The year to date NAV total return was -2.1% and the share price total return was -14.7%. Over the same period, the Company's two indices; RPI plus 3% and MSCI All Country World Index (50% Sterling) were up +2.0% and down -2.8% respectively. The average net quoted equity exposure for the year to date was 42%. The share price closed at 1,786 pence per share.











