

# Financial Summary

The net asset value (NAV) per share at 30 September was 2,737 pence. The year to date NAV total return was 20.2% and the share price total return was 25.5%. Over the same period, the Company's two indices; RPI plus 3% and MSCI All Country World Index (50% Sterling) were up 5.9% and 12.8% respectively. The average net quoted equity exposure for the year to date was 44%. The share price closed at 2,555 pence per share, having gone ex-dividend on 30 September 2021.








## Currency Exposure (% of NAV)<sup>3</sup>


