To invest in a widely diversified, international portfolio across a range of asset classes, both quoted and unquoted;

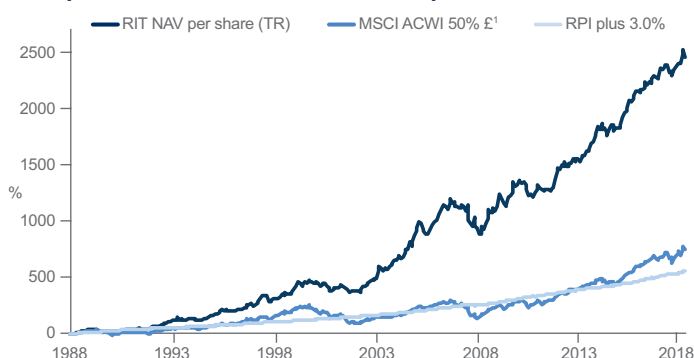
to allocate part of the portfolio to exceptional managers in order to ensure access to the best external talent available.

Financial Summary

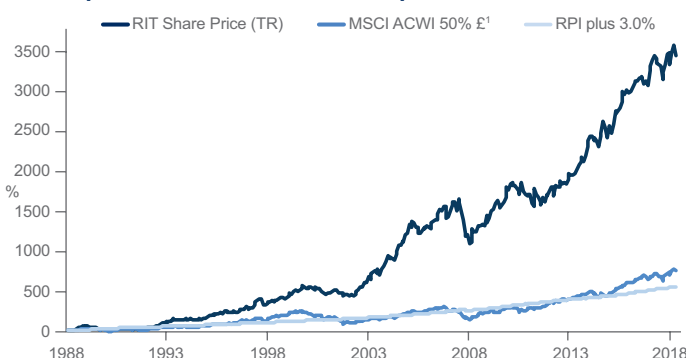
The net asset value (NAV) per share at 31 August was 1,964 pence. The year to date NAV total return was +8.8% and the share price total return was +11.9%. Over the same period, the Company's two indices; RPI plus 3% and MSCI All Country World Index (50% Sterling) were up +3.8% and +16.9% respectively. The average net quoted equity exposure for the year to date is 44%. The share price closed at 2,120 pence per share.

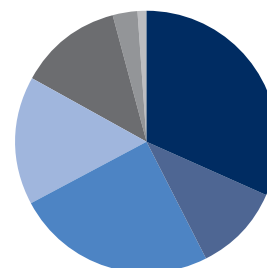

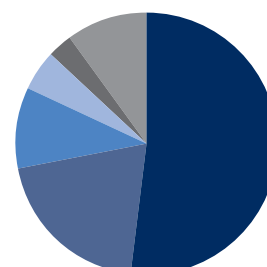

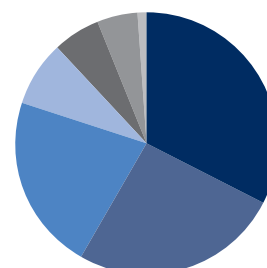

RIT Capital Partners plc (RIT) is an investment trust chaired by Lord Rothschild, which aims to deliver long-term capital growth, while preserving shareholders' capital. J. Rothschild Capital Management (JRCM) is a wholly-owned subsidiary of RIT and acts as RIT's Manager. Since listing on the London Stock Exchange in 1988, RIT has generated a share price total return of 12.1% per annum for its shareholders⁵. £10,000 invested in RIT at inception in 1988 would be worth ~£326,000 today⁵ (with dividends reinvested) compared to the same amount invested in the ACWI¹ which would be worth ~£73,000⁵.
